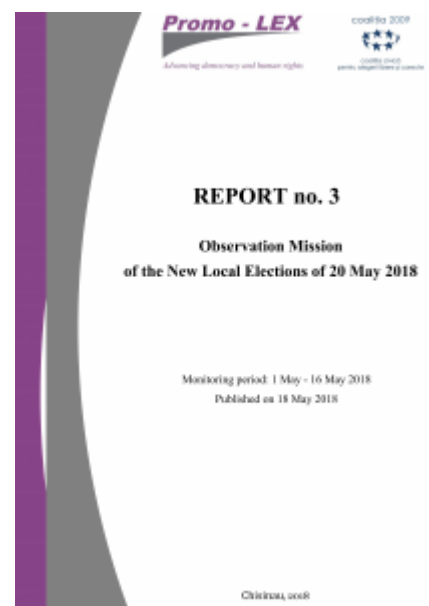


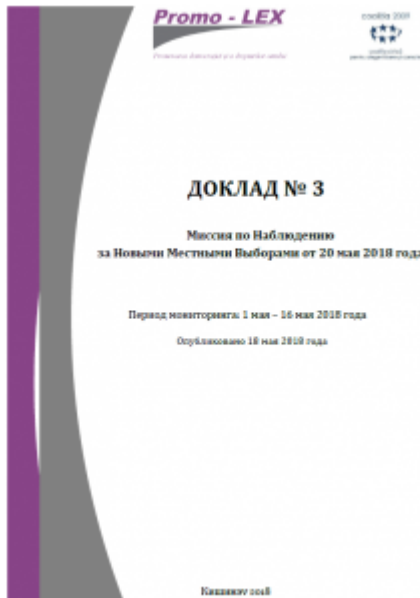
Promo-LEX | Preliminary results of parallel vote counting
